SECRETARY REPORT

PRESIDENT – TREASURER REPORT

Financial Update

The 2nd quarter financial reports will be prepared and distributed to the board members via Basecamp.

The SEF 990 tax forms:

Federal has been finished and submitted.

State 990 needs final signatures of officers; and extension has been obtained, and the form will be submitted when signatures obtained.

We continue to update appropriate access and signatures to the SEF accounts.

COPA TRAINING

Video Project

LMS video launch has been very well received (over 100 enrolled in the G2 course).

It has prompted a spike in log-ins (>100 per day), with almost 600 total logged in.

This will require increasing the license number to 800 users.

The costs are relative to user numbers, so the budget for this will be adjusted.

<u>CPPP</u>

The one-day course in Aurora was cancelled; some of the attendees have transferred to the Sacramento 3 day course.

It has been noted that registrations for the courses does seem to be positively affected by COPA posts and mailings.

There was a brief discussion of some upcoming dates:

- Sacramento course is filling
- Migration will have 'shorter' classes
- Australia is starting to get registration (20 already)

The venues for 2025 are already being booked. Concurrently this requires defining and then placing deposits (funds)

Melbourne, Waukesha, Palm Springs (and possibly Fort Collins) have been booked.

FUNDRAISING

Fundraising events

The group discussed our "Elevate 2024" campaign and Migration fundraising plans. The ability to do live streaming during the Migration event will be investigated.

There will not be any formal fundraising or announcements at the Oshkosh Airventure COPA dinner, although multiple SEF Board members will be attending.
